**CIRCULAR**

Applications are invited from Advocates having three (3) years or above practice in High Court and District Courts and are willing to be being empanelled as a Panel Lawyer for the Arunachal Pradesh State Legal Services Authority (APSLSA) in the District Courts for a period of three (3) years as per the eligibilities norms as shown below:

1. Length of Practice-three (3) years or above.

All applications for such empanelment should be accompanied by Bar Council Registration Certificates along with brief resume of the applicant addressed to the Chairman of the District Legal Services Authority for onward forward to the Member Secretary, Arunachal Pradesh State Legal Services Authority (APSLSA). And application received shall be forwarded by the concerned Chairman to the office of the undersigned on or before 30<sup>th</sup> July 2021. No further applications would be entertained thereafter.

**NB:** 1. *It may be noted that the list of Panel lawyer of APSLSA would be published afresh, therefore all the existing LACs should also apply. And further taking into consideration the Austerity measures, only limited No. Of LAC would be empanelled.*

**REGULATIONS /PROCEDURES FOR SELECTION OF LAWYERS FOR EMPANELMENT IN THE PANEL OF APSLSA:**

1. The APSLSA shall invite applications from willing and dedicated legal practitioners for their empanelment as panel lawyers for a period of three years.
2. Such application shall be addressed to the Chairman, District Legal Services Authority for Districts.
3. Such applications shall be accompanied with proof of the professional experience like Bar Council Registration Certificates, Enrolment Certificate/ID Card of the concerned bar where he/she is practicing, along with brief resume of the applicant.
4. The legal practitioner should have minimum three years of professional experience for District Courts for empanelment.
5. The competency, integrity, suitability and dedication of the applicant shall be taken into account apart from his/her professional experience while empanelment.
6. The Chairman, District Legal Services Authority, after the scrutiny of the applications so received under Regulation 1 of *The National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010 (Amended 2019)* shall forward the same to the Member Secretary, Arunachal Pradesh State Legal Services Authority for approval and empanelment thereby.
7. The application so forwarded under Regulation 6 of *The National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010 (Amended 2019)* shall be scrutinized and selection of panel lawyers shall be made by the Member Secretary, APSLSA after consultation with the Chairman/Secretary District Legal Services Authorities.
8. The Member Secretary, APSLSA, shall get the panel lists so maintained under Regulation 8 of *The National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010 (Amended 2019)* approved from the Executive Chairman of APSLSA.
